

This Quantum PKI Toolkit Demo End User License Agreement, including the Order Form (if any) which by this reference is incorporated herein (this "EULA"), is a binding agreement between Sectigo Limited, with registered number 04058690 and with registered offices at 3rd Floor, 26 Office Village, Exchange Quay, Trafford Road, Salford, Manchester, M5 3EQ, United Kingdom ("Sectigo") and the person or entity that downloads and/or uses the Software ("Licensee").

SECTIGO PROVIDES THE SOFTWARE SOLELY ON THE TERMS AND CONDITIONS SET FORTH IN THIS EULA AND ON THE CONDITION THAT LICENSEE ACCEPTS AND COMPLIES WITH THEM. BY DOWNLOADING THE SOFTWARE, YOU (A) ACCEPT THIS EULA AND AGREE THAT LICENSEE IS LEGALLY BOUND BY ITS TERMS; AND (B) REPRESENT AND WARRANT THAT: (I) YOU ARE 18 YEARS OF AGE OR OLDER OF LEGAL AGE TO ENTER INTO A BINDING AGREEMENT; AND (II) IF LICENSEE IS A CORPORATION, GOVERNMENTAL ORGANIZATION, OR OTHER LEGAL ENTITY, YOU HAVE THE RIGHT, POWER, AND AUTHORITY TO ENTER INTO THIS EULA ON BEHALF OF LICENSEE AND BIND LICENSEE TO ITS TERMS. IF LICENSEE DOES NOT AGREE TO THE TERMS OF THIS EULA, SECTIGO WILL NOT AND DOES NOT LICENSE THE SOFTWARE TO LICENSEE AND YOU MUST NOT DOWNLOAD THE SOFTWARE OR DOCUMENTATION.

NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS EULA OR YOUR OR LICENSEE'S ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS EULA, NO LICENSE IS GRANTED (WHETHER EXPRESSLY, BY IMPLICATION, OR OTHERWISE) UNDER THIS EULA, AND THIS EULA EXPRESSLY EXCLUDES ANY RIGHT, CONCERNING ANY SOFTWARE THAT LICENSEE DID NOT ACQUIRE LAWFULLY OR THAT IS NOT A LEGITIMATE, AUTHORIZED COPY OF SECTIGO'S SOFTWARE.

- Definitions. For purposes of this EULA, the following terms have the following meanings:
- "Authorized Users" means the individual employees or contractors of Licensee who Licensee permits to access and use the Software and/or Documentation pursuant to Licensee's license hereunder.
- "Data Protection Legislation" means applicable data protection legislation relating to personal data and other legislation and regulatory requirements in force from time to time which apply to a party relating to the use of personal data.
- "Documentation" means user manuals, technical manuals, and any other materials provided by Sectigo, in printed, electronic, or other form, that describe the installation, operation, use, or technical specifications of the Software.
- "Intellectual Property Rights" means any and all registered and unregistered rights granted, applied for, or otherwise now or hereafter in existence under or related to any patent, copyright, trademark, trade secret, database protection, or other intellectual property rights laws, and all similar or equivalent rights or forms of protection, in any part of the world.
- "Licensee" has the meaning set forth in the preamble.
- "License Fees" means the license fees, including all taxes thereon, charged by Sectigo and paid or required to be paid by Licensee, for the license granted under this EULA.
- "Order Form" means the order form filled out and submitted by or on behalf of Licensee, and accepted by Sectigo in writing, for Licensee's purchase of the license for the Software granted under this EULA.
- "Person" means an individual, corporation, partnership, joint venture, limited liability company, governmental authority, unincorporated organization, trust, association, or other entity.
- "**Personal Data**" shall have the meaning as defined in the applicable Data Protection Legislation.
- "Sectigo" has the meaning set forth in the preamble.
- "Software" means the software programs downloaded with this EULA, or for which Licensee is purchasing a license as expressly set forth in the Order Form.



"Support Fees" means the fees, including all taxes thereon, charged by Sectigo and paid or required to be paid by Licensee, for technical or customer support or maintenance of the Software.

"Term" has the meaning set forth in Section 11.

"Third Party" means any Person other than Licensee or Sectigo.

- <u>License Grant and Scope</u>. Subject to and conditioned upon Licensee's payment of the License Fees (if applicable) 2. and Licensee's strict compliance with all terms and conditions set forth in this EULA, Sectigo hereby grants to Licensee a non-exclusive, non-transferable, non-sublicensable, limited license during the Term to use, solely by and through its Authorized Users, the Software and Documentation, solely as set forth in this Section 2 and subject to all conditions and limitations set forth in Section 4 or elsewhere in this EULA. This license grants Licensee the right, exercisable solely by and through Licensee's Authorized Users, to:
- (a) Download and install in accordance with the Documentation one (1) copy of the Software on one (1) computer owned or leased, and controlled by, Licensee. In addition to the foregoing, Licensee may make one copy of the Software solely for archival purposes and one copy of the Software solely for backup purposes, provided that Licensee shall not, and shall not allow any Person to, install or use any such copy other than if and for so long as the copy installed in accordance with the preceding sentence is inoperable and, provided, further, that Licensee uninstalls and otherwise deletes such inoperable copy(ies). All copies of the Software made by the Licensee:
 - (i) will be the exclusive property of Sectigo;
 - will be subject to the terms and conditions of this EULA; and (ii)
 - must include all trademark, copyright, patent, and other Intellectual Property Rights notices contained in (iii) the original.
- Use and run the Software as properly installed in accordance with this EULA and the Documentation, solely as (b) set forth in the Documentation and solely for Licensee's internal testing purposes.
- Download or otherwise make one (1) copy of the Documentation per copy of the Software permitted to be (c) downloaded and installed in accordance with this EULA and use such Documentation, solely in support of its licensed use of the Software in accordance herewith. All copies of the Documentation made by Licensee:
 - (i) will be the exclusive property of Sectigo;
 - will be subject to the terms and conditions of this EULA; and (ii)
 - (iii) must include all trademark, copyright, patent, and other Intellectual Property Rights notices contained in the original.
- (d) Transfer any copy of the Software from one computer to another, provided that the number of computers on which the Software is installed at any one time does not exceed the number permitted under Section 2(a).
- Third-Party Materials. The Software may include software, content, data, or other materials, including related documentation, that are owned by Persons other than Sectigo and that are provided to Licensee on licensee terms that are in addition to and/or different from those contained in this EULA ("Third-Party Licenses"). A list of all materials, if any, included in the Software and provided under Third-Party Licenses can be found at www.sectigo.com and the applicable Third-Party Licenses are accessible via links therefrom. Licensee is bound by and shall comply with all Third-Party Licenses. Any breach by Licensee or any of its Authorized Users of any Third-Party License is also a breach of this EULA.
- 4. Use Restrictions. Licensee shall not, and shall require its Authorized Users not to, directly or indirectly:
- use (including make any copies of) the Software or Documentation beyond the scope of the license granted under (a) Section 2;
- provide any other Person, including any subcontractor, independent contractor, affiliate, or service provider of Licensee, with access to or use of the Software or Documentation;



- modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of the (c) Software or Documentation or any part thereof;
- reverse engineer, disassemble, decompile, decode, or otherwise attempt to derive or gain access to the source code of the Software or any part thereof;
- (e) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices provided on or with the Software or Documentation, including any copy thereof;
- except as expressly set forth in Section 2(a) and Section 2(c), copy the Software or Documentation, in whole or in part;
- rent, lease, lend, sell, sublicense, assign, distribute, publish, transfer, or otherwise make available the Software, or (g) any features or functionality of the Software, to any Third Party for any reason, whether or not over a network or on a hosted basis, including in connection with the internet or any web hosting, wide area network (WAN), virtual private network (VPN), virtualization, time-sharing, service bureau, software as a service, cloud, or other technology or service;
- use the Software or Documentation in, or in association with, the design, construction, maintenance, or operation of any hazardous environments or systems, including: (i) power generation systems; (ii) aircraft navigation or communication systems, air traffic control systems, or any other transport management systems; (iii) safety-critical applications, including medical or life-support systems, vehicle operation applications, or any police, fire, or other safety response systems; and (iv) military or aerospace applications, weapons systems, or environments;
- use the Software or Documentation in violation of any law, regulation, or rule; or (i)
- use the Software or Documentation for purposes of competitive analysis of the Software, the development of a competing software product or service, or any other purpose that is to Sectigo's commercial disadvantage.
- Responsibility for Use of Software. Licensee is responsible and liable for all uses of the Software and Documentation through access thereto provided by Licensee, directly or indirectly. Specifically, and without limiting the generality of the foregoing, Licensee is responsible and liable for all actions and failures to take required actions with respect to the Software and Documentation by its Authorized Users or by any other Person to whom Licensee or an Authorized User may provide access to or use of the Software and/or Documentation, whether such access or use is permitted by or in violation of this EULA.

6. Compliance Measures.

- The Software may contain technological copy protection or other security features designed to prevent (a) unauthorized use of the Software, including features to protect against any use of the Software that is prohibited under Section 4. Licensee shall not, and shall not attempt to, remove, disable, circumvent, or otherwise create or implement any workaround to, any such copy protection or security features.
- Upon on Sectigo's written request, Licensee shall conduct a review of its and its Authorized Users use the Software and certify to Sectigo in a written instrument signed by an officer of Licensee that it is in full compliance with this EULA or, if Licensee discovers any noncompliance:
 - Licensee shall immediately remedy such noncompliance and provide Sectigo with written notice thereof. Licensee shall provide Sectigo with all access and assistance as Sectigo requests to further evaluate and remedy such noncompliance.
 - (ii) If Licensee's use of the Software exceeds the number of copies or Authorized Users permitted under the license, Sectigo shall have the remedies set forth in Section Error! Reference source not found.
- During the Term, Sectigo may, in Sectigo's sole discretion, audit Licensee's use of the Software to ensure Licensee's compliance with this EULA, provided that (i) any such audit shall be conducted on not less than thirty (30) days' prior notice to Licensee, and (ii) no more than one (1) audit may be conducted in any twelve (12) month period except for good cause shown. Sectigo also may, in its sole discretion, audit Licensee's systems within three (3) months after the end of the Term to ensure Licensee has ceased use of the Software and removed the all copies of the Software



from such systems as required hereunder. The Licensee shall reasonably cooperate with Sectigo's personnel conducting such audits and provide all reasonable access requested by Sectigo to records, systems, equipment, information, and personnel, including machine IDs, serial numbers, and related information. Sectigo shall only examine information directly related to the Licensee's use of the Software. Sectigo may conduct audits only during Licensee's normal business hours and in a manner that does not unreasonably interfere with the Licensee's business operations.

- Maintenance and Support. Sectigo is not obligated to provide technical or customer support or maintenance for the Software. In the event Sectigo offers or includes technical or customer support or maintenance for the Software, Sectigo has the right to alter or terminate such support and maintenance (i) at any time, if no Support Fees are charged by Sectigo or paid by Licensee, or (ii) in accordance with the applicable support agreement agreed to between Sectigo and Licensee, if Support Fees are charged by Sectigo and paid by Licensee.
- Data Protection; Collection and Use of Information.
- (a) Data Protection. Sectigo shall be responsible for establishing and maintaining a commercially reasonable information security program that (i) complies with applicable Data Protection Legislation applicable to Sectigo and the Software and (ii) is designed to: (a) protect the security and confidentiality of Licensee's Personal Data; (b) protect against anticipated threats or hazards to the security or integrity of the Licensee's Personal Data; (c) protect against unauthorized access, use or loss of Licensee's Personal Data; and (d) require that all subcontractors of Sectigo who will be accessing the Licensee's Personal Data, if any, comply with the foregoing. Each party shall notify the other party promptly of any unauthorized access or use of which it becomes reasonably aware. In circumstances where the Licensee or Sectigo are outside the European Economic Area ("EEA") and Licensee's Personal Data is processed or transferred pursuant to this EULA to or from the EEA, such transfer shall be made with Sectigo only based on an EU Standard Contractual Clauses form as agreed by Licensee. Neither Party shall assume responsibility for the other Party for any breach of such Party's obligations under applicable Data Protection Legislation.
- Collection. Licensee acknowledges that Sectigo may, directly or indirectly through the services of Third Parties, collect and store information regarding use of the Software and about equipment on which the Software is installed or through which it otherwise is accessed and used, through: (i) the provision of maintenance and support services; and (ii) security measures included in the Software as described in Section 6.
- (c) Privacy Policy. Sectigo shall follow its Privacy Policy when receiving and using information about Licensee. Sectigo may amend its Privacy Policy at any time in accordance with the process outlined therein. Sectigo shall use reasonable efforts in protecting Licensee's Personal Data. As used herein, "Privacy Policy" shall mean the most current version of Sectigo's privacy policy as found on its website.
- Intellectual Property Rights. Licensee acknowledges and agrees that the Software and Documentation are provided under license, and not sold, to Licensee. Licensee does not acquire any ownership interest in the Software or Documentation under this EULA, or any other rights thereto, other than to use the same in accordance with the license granted and subject to all terms, conditions, and restrictions under this EULA. Sectigo and its licensors and service providers reserve and shall retain their entire right, title, and interest in and to the Software and all Intellectual Property Rights arising out of or relating to the Software, except as expressly granted to the Licensee in this EULA. Licensee shall use commercially reasonable efforts to safeguard all Software (including all copies thereof) from infringement, misappropriation, theft, misuse, or unauthorized access. Licensee shall promptly notify Sectigo if Licensee becomes aware of any infringement of Sectigo's Intellectual Property Rights in the Software and fully cooperate with Sectigo in any legal action taken by Sectigo to enforce its Intellectual Property Rights.
- Payment. To the extent applicable, all License Fees and Support Fees are payable in advance in the manner set forth in the Order Form and are non-refundable. Any renewal of the license or maintenance and support services hereunder shall not be effective until the fees for such renewal have been paid in full.

11. Term and Termination.

This EULA and the license granted hereunder shall remain in effect for (i) the term set forth on the Order Form, if (a) a license to use the Software was purchased using an Order Form, or (ii) until earlier terminated as set forth herein (the



"Term").

- Licensee may terminate this EULA by ceasing to use and destroying all copies of the Software and (b) Documentation.
- Sectigo may terminate this EULA, effective upon notice to Licensee, (i) for convenience, or (ii) if Licensee, materially breaches this EULA and such breach: (a) is incapable of cure; or (b) being capable of cure, remains uncured thirty (30) days after Sectigo provides written notice thereof.
- Sectigo may terminate this EULA, effective immediately, if Licensee files, or has filed against it, a petition for voluntary or involuntary bankruptcy or pursuant to any other insolvency law, makes or seeks to make a general assignment for the benefit of its creditors or applies for, or consents to, the appointment of a trustee, receiver, or custodian for a substantial part of its property.
- (e) Upon expiration or earlier termination of this EULA, the license granted hereunder shall also terminate, and Licensee shall cease using and destroy all copies of the Software and Documentation. No expiration or termination shall affect Licensee's obligation to pay all Licensee Fees and Support Fees that may have become due before such expiration or termination, or entitle Licensee to any refund.
- Warranty Disclaimer. THE SOFTWARE AND DOCUMENTATION ARE PROVIDED TO LICENSEE "AS IS" 12. AND WITH ALL FAULTS AND DEFECTS WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, SECTIGO, ON ITS OWN BEHALF AND ON BEHALF OF ITS AFFILIATES AND ITS AND THEIR RESPECTIVE LICENSORS AND SERVICE PROVIDERS, EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, WITH RESPECT TO THE SOFTWARE AND DOCUMENTATION, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, AND WARRANTIES THAT MAY ARISE OUT OF COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE, OR TRADE PRACTICE. WITHOUT LIMITATION TO THE FOREGOING, SECTIGO PROVIDES NO WARRANTY OR UNDERTAKING, AND MAKES NO REPRESENTATION OF ANY KIND THAT THE LICENSED SOFTWARE WILL MEET THE LICENSEE'S REQUIREMENTS, ACHIEVE ANY INTENDED RESULTS, BE COMPATIBLE, OR WORK WITH ANY OTHER SOFTWARE, APPLICATIONS, SYSTEMS, OR SERVICES, OPERATE WITHOUT INTERRUPTION, MEET ANY PERFORMANCE OR RELIABILITY STANDARDS OR BE ERROR FREE, OR THAT ANY ERRORS OR DEFECTS CAN OR WILL BE CORRECTED.
- 13. Limitation of Liability. TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW:
- (a) IN NO EVENT WILL SECTIGO OR ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE LICENSORS OR SERVICE PROVIDERS, BE LIABLE TO LICENSEE OR ANY THIRD PARTY FOR ANY USE, INTERRUPTION, DELAY, OR INABILITY TO USE THE SOFTWARE: LOST REVENUES OR PROFITS: DELAYS. INTERRUPTION, OR LOSS OF SERVICES, BUSINESS, OR GOODWILL; LOSS OR CORRUPTION OF DATA; LOSS RESULTING FROM SYSTEM OR SYSTEM SERVICE FAILURE, MALFUNCTION, OR SHUTDOWN; FAILURE TO ACCURATELY TRANSFER, READ, OR TRANSMIT INFORMATION; FAILURE TO UPDATE OR PROVIDE CORRECT INFORMATION; SYSTEM INCOMPATIBILITY OR PROVISION OF INCORRECT COMPATIBILITY INFORMATION; OR BREACHES IN SYSTEM SECURITY; OR FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL, OR PUNITIVE DAMAGES, WHETHER ARISING OUT OF OR IN CONNECTION WITH THIS EULA, BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT SECTIGO WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- IN NO EVENT WILL SECTIGO'S AND ITS AFFILIATES', INCLUDING ANY OF ITS OR THEIR RESPECTIVE LICENSORS' AND SERVICE PROVIDERS', COLLECTIVE AGGREGATE LIABILITY UNDER OR IN CONNECTION WITH THIS EULA OR ITS SUBJECT MATTER, UNDER ANY LEGAL OR EQUITABLE THEORY, INCLUDING BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, AND OTHERWISE, EXCEED: (i) THE TOTAL AMOUNT PAID TO SECTIGO PURSUANT TO THIS EULA FOR THE SOFTWARE UP TO TWELVE (12) MONTHS OF THE SPECIFIC SERVICES THAT IS OR ARE THE



SUBJECT OF THE CLAIM, OR (ii) ONE HUNDRED DOLLARS (\$100).

- THE LIMITATIONS SET FORTH IN SECTION 13(a) AND SECTION 13(b) SHALL APPLY EVEN IF THE (c) LICENSEE'S REMEDIES UNDER THIS EULA FAIL OF THEIR ESSENTIAL PURPOSE.
- Export Regulation. The Software and Documentation, and any products utilizing any such Software, Documentation, or other technical data (collectively, "Regulated Products") may be subject to applicable export control laws and regulations, including, in the UK, the Dual-Use Regulation (428/2009), the Export Control Act 2002, and the Export Control Order 2008 (SI 2008/3231), and in the US, the Export Administration Regulations and the International Traffic in Arms Regulations. Licensee shall not, and shall not permit any Third Parties to, directly or indirectly, export, reexport, or release any Regulated Products to any jurisdiction or country to which, or any party to whom, the export, reexport, or release of any Regulated Products is prohibited by applicable federal or foreign law, regulation, or rule. The Licensee shall be responsible for any breach of this section by its, and its successors' and permitted assigns', parent, affiliates, employees, officers, directors, partners/members/shareholders, customers, agents, distributors, resellers, or vendors. The Licensee shall comply with all applicable federal and foreign laws, regulations, and rules, and complete all required undertakings (including obtaining any necessary export license or other governmental approval), prior to exporting, reexporting, or releasing any Regulated Products. The Licensee shall provide prior written notice of the need to comply with such laws and regulations to any person, firm, or entity which it has reason to believe is obtaining any such Regulated Products from the Licensee with the intent to export or reexport.
- 15. US Government Rights. The Software is commercial computer software, as such term is defined in 48 C.F.R. §2.101. Accordingly, if the Licensee is the US Government or any contractor therefor, Licensee shall receive only those rights with respect to the Software and Documentation as are granted to all other end users under license, in accordance with (a) 48 C.F.R. §227.7201 through 48 C.F.R. §227.7204, with respect to the Department of Defense and their contractors, or (b) 48 C.F.R. §12.212, with respect to all other US Government licensees and their contractors.

16. Miscellaneous.

- All matters arising out of or relating to this EULA shall be governed by and construed in accordance with the (a) internal laws of the State of New Jersey without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding arising out of or relating to this EULA or the transactions contemplated hereby shall be instituted in the federal courts of the United States of America or the courts of the State of New Jersey, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such legal suit, action, or proceeding. Service of process, summons, notice, or other document by mail to such party's address set forth herein shall be effective service of process for any suit, action, or other proceeding brought in any such court.
- Sectigo will not be responsible or liable to Licensee, or deemed in default or breach hereunder by reason of any failure or delay in the performance of its obligations hereunder where such failure or delay is due to strikes, labor disputes, civil disturbances, riot, rebellion, invasion, epidemic, hostilities, war, terrorist attack, embargo, natural disaster, acts of God, flood, fire, sabotage, fluctuations or non-availability of electrical power, heat, light, air conditioning, or Licensee equipment, loss and destruction of property, or any other circumstances or causes beyond Sectigo's reasonable control.
- All notices, requests, consents, claims, demands, waivers, and other communications hereunder shall be in writing and shall be deemed to have been given: (i) when delivered by hand (with written confirmation of receipt); (ii) when received by the addressee if sent by a nationally recognized overnight courier (receipt requested); (iii) on the date sent by facsimile or email (with confirmation of transmission) if sent during normal business hours of the recipient, and on the next business day if sent after normal business hours of the recipient; or (iv) on the third day after the date mailed, by certified or registered mail, return receipt requested, postage prepaid. Such communications must be sent to the respective parties at the addresses set forth on the Order Form (if applicable) or to such other address as may be designated by a party from time to time in accordance with this section.
- This EULA, together with any applicable Order Form, all annexes, schedules, and exhibits attached hereto and all other documents that are incorporated by reference herein, constitutes the sole and entire agreement between Licensee and Sectigo with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings,



agreements, representations, and warranties, both written and oral, with respect to such subject matter.

- Licensee shall not assign or otherwise transfer any of its rights, or delegate or otherwise transfer any of its obligations or performance, under this EULA, in each case whether voluntarily, involuntarily, by operation of law, or otherwise, without Sectigo's prior written consent, which consent Sectigo may give or withhold in its sole discretion. For purposes of the preceding sentence, and without limiting its generality, any merger, consolidation, or reorganization involving Licensee (regardless of whether Licensee is a surviving or disappearing entity) will be deemed to be a transfer of rights, obligations, or performance under this EULA for which Sectigo's prior written consent is required. No delegation or other transfer will relieve Licensee of any of its obligations or performance under this EULA. Any purported assignment, delegation, or transfer in violation of this section is void. Sectigo may freely assign or otherwise transfer all or any of its rights, or delegate or otherwise transfer all or any of its obligations or performance, under this EULA without Licensee's consent. This EULA is binding upon and inures to the benefit of the parties hereto and their respective permitted successors and assigns.

Unless the context otherwise requires, references herein: (x) to Sections, Annexes, Schedules, and Exhibits refer to the Sections of, and Annexes, Schedules, and Exhibits attached to, this EULA; (v) to an agreement, instrument, or other document means such agreement, instrument, or other document as amended, supplemented, and modified from time to time to the extent permitted by the provisions thereof and (z) to a statute means such statute as amended from time to time and includes any successor legislation thereto and any regulations promulgated thereunder. This EULA shall be construed without regard to any presumption or rule requiring construction or interpretation against the party drafting an instrument or causing any instrument to be drafted. Any applicable Order Form and all Annexes, Schedules, and Exhibits referred to herein shall be construed with, and as an integral part of, this EULA to the same extent as if they were set forth verbatim herein.
